

### **The Effects of Ultroid®**

• Ultroid<sup>®</sup> applies a very low direct current to the base of the hemorrhoid.

• Ultroid<sup>®</sup> causes a reaction in tissues that results in regression of the hemorrhoid.

• In theory, the effect of Ultroid<sup>®</sup> is a chemical reaction which results in thrombosis of the feed-ing vessel.



The actual mechanism of action to bring about resolution of hemorrhoidal disease is currently under research in the laboratories of the University of South Florida.

- 120 patients 590 hemorrhoid segments
  - 114: grade I segments
- 222: grade II segments
  76: grade IV segments
- 178: grade III segments
- Results
  - No treatment failures
  - 99/120 patients complete ablation of all hemorrhoid disease
  - 21/120 patients had asymptomatic residual grade I disease
  - All 120 patients remained symptom-free at a mean duration of follow-up of 23 months

**Good Result: complete resolution of symptoms** 

Fair Result: marked improvement in symptoms but still had minor discomfort or occasional spotting

- Ultroid more effective for grades I and II and significantly more effective for grades III with less discomfort and bleeding Good Result in 95.2% of grades I and II and 85% grade III Minor bleeding in 2% of patients and pain in 29%

Good Result in 93.7% of grade I and II and 23.1% of grade III Minor bleeding in 19.9% and pain in 29%

Heater Probe

Good Result in 94% of grade I and II and 5.9% of grade III Bleeding in 9.4% and pain in 9.4%
